Dear Congressman Radanovich:

The Tuolumne Band of Me-Wuk Indians fully supports the efforts of the nonprofit group Restore Hetch Hetchy. We ask you to support one million dollars in

funding for a Feasibility Study to demonstrate win-win options for the restoration of Hetch Hetchy Valley and for the San Francisco Bay Area water and power users.

Ron Good, Executive Director of Restore Hetch Hetchy, has acknowledged Hetch Hetchy Valley as our homeland, and we appreciate that he has involved us early in the planning process. We agree that exploration of possibilities for restoration of Hetch Hetchy Valley is timely and realistic based on the existence of and potential for other options for energy generation and



water storage, and current and future repair and maintenance needs for existing Hetch Hetchy water and energy delivery systems.

The Me-Wuk Tribe knows that restoration is a process that would span generations. As this project evolves it is imperative that the perspective and desires of members of the Me-Wuk Tribe, and those of other tribes with ties to Hetch Hetchy Valley, be incorporated into the planning and implementation

process. Formal Agreements must be set in place among all concerned at each juncture. The Me-Wuk Tribe is committed to remaining involved, over time, with this project.

Thank you for supporting Restore Hetch Hetchy with one million dollars in funding for an initial Feasibility Study.

Meet Our Board: Marsh Pitman

arsh Pitman readily embraced the prospect of a restored Hetch Hetchy Valley in Yosemite National Park when he first heard about it from Ron Good in 1997.

Marsh got so enthused that he and his wife, Carol, hosted the June1999 meeting at their Merced, California home where those assembled agreed to form Restore Hetch Hetchy as an independent non-profit entity and serve as initial members of the Board of Directors.

Marsh's interest in Yosemite started from family stories of travel by mule team and wagon from Modesto, and adventures of camping for a month at a time in Tuolumne Meadows during the summers from 1912 to 1916. The stories and photographs on the walls of his grandparent's home were reinforced by Marsh's first visit to the Tuolumne River watershed, thanks to his grandparents. They patiently stopped just east of Tioga Pass so their 13 year-old grandson could ascend to 10,000foot elevation for the first time. before visiting their beloved Tuolumne Meadows once again. Grandmother Pitman had the makings of lemonade to add to the water of the Soda Springs as he heard some stories of their experiences repeated yet again.

Marsh was fortunate to be selected for the 1950 class of the

Yosemite Field School of Natural History, a National Park Service training program for naturalists, in the summer following his BA in Biological Sciences from San Jose State. He worked as a seasonal naturalist in Yosemite for the summer of 1951. Marsh's graduate study at Stanford in Education and in Botany at the University of Arizona and other studies have contributed to his teaching career in Hayward, California and then in Merced - closer to Yosemite. During his tenure as a life sciences instructor at Merced College, Marsh initiated the Environmental Science course. He was able to arrange for students from Merced to be introduced to museum techniques as they provided needed assistance to the curator of the Yosemite Museum in 1970. Marsh has had a variety of roles as naturalist, outings leader, and tour leader in California, Switzerland, Alaska, Hawaii, New Zealand, Ecuador, Peru, Kenya, Tanzania, and Rwanda.

Marsh has been a community environmental leader in interacting with administrators and planners of the new campus of the University of California - Merced. Through the efforts of many concerned citizens, the UC Merced campus will be situated in a more eco-friendly location, and with a greater awareness of environmental concerns by



RHH Feasibility Study UPDATE



estore Hetch Hetchy volunteers and staff have been hard at work preparing our Feasibility Study, and hope to have it ready by the end of summer!

The completion of our Feasibility Study will represent a very significant milestone for Restore Hetch Hetchy, as it will make recommendations for removing the O'Shaughnessy Dam in an environmentally sensitive manner, supporting natural restoration processes, and examining alternative water storage and electrical power options.

Dr. Jerry Meral, the former Executive Director of the Planning & Conservation League, is the primary "mover and shaker" for our Feasibility Study. Bob Hackamack, the Chair of our Technical/Engineering Committee, and Spreck Rosekrans, another member of the Committee, have been invaluable participants. All three are members of our Board of Directors. And, graphic artists Jef Gunion from Felton and Diane Blakely from Penn Valley are doing a wonderful job of presenting the material in a visually pleasing manner. Please see the above photo of a draft of the front cover of the Feasibility Study that our graphic artists have prepared. The top image of Hetch Hetchy is by artist Brooks Anderson, and the bottom image is by

photographer Tony Dunn. On June 27th, Jerry will present a draft of the Feasibility Study to the Board of Directors.

While many people have volunteered their time and incredible talents toward the Feasibility Study, such a project is not without substantial costs. But, incalculable benefits will ultimately result from a restored Hetch Hetchy Valley in Yosemite National Park. Thanks very much to so many of you who made special contributions for the research, production, and distribution of the Feasibility Study.

Testimonial for "Hetch Hetchy: Yosemite's Lost Valley" documentary film

HH Executive Director, Ron Good, received this e-mail from RHH member Guy Ward from Richmond, Virginia:

Thanks for sending the DVD copy of your new documentary film: "Hetch Hetchy: Yosemite's Lost Valley." I thought it was excellent!

The film footage of Tueeulala Fall rekindled one of my fondest memories of Yosemite National Park. On my last visit to the park in May 2000 I hiked the Hetch Hetchy trail twice. On the first hike, Tueeulala was only a delicate wisp. But, by the end of the week, a surge of warm weather had transformed it into the waterfall that Muir described, as "the most graceful waterfall I have ever seen."

I was so excited to see it like that, I left the trail and climbed up the talus slope to a point almost right beside it. I found a flat rock slab and just laid there for over an hour looking up at the mix of comets and veils plunging downward toward me. Even better, nobody else was around, not even on the main trail. I couldn't believe I had such an amazing sight all to myself. Seeing Tueeulala Fall like that just made the whole experience very special. And Wapama Fall was roaring as usual.

The views that John Muir had of Tueeulala Fall, Wapama Fall, and Kolana Rock from Hetch Hetchy's meadows must have been breathtaking. I think if we all had Hetch Hetchy Valley to hike through with meadows, the two great waterfalls, groves of trees, and a free flowing river, it would be as rewarding an experience as any in the national park system. And, I've seen many of our nation's best parks over the last 15 years, east and west.

I'm a latecomer to Yosemite.

only visiting the park for the first time in 1996. I fell in love with it immediately and was shocked to learn about the other great valley (Hetch Hetchy) in Yosemite, and what happened to it. I live 3,000 miles away and wasn't born until 1958, decades after the dam was built, but I felt like I had been robbed. Hetch Hetchy Valley would have been the place for me.

The work your group is doing makes me certain that one day I'll be able to stand on the Hetch Hetchy Valley floor and see it in all its glory. When the ceremony occurs decommissioning the dam and starting the restoration process I want to at least be able to say I had a small part in making that great day happen.


RHH Office Moves to Sonora!
